Dear Chairman Rehberg and Ranking Member DeLauro:

On behalf of the 3.1 million nurses who serve as the backbone of our nation's healthcare system, the 50 undersigned organizations of the Nursing Community are writing to respectfully request your support for increased funding in fiscal year (FY) 2012 for the Nursing Workforce Development programs authorized under Title VIII of the Public Health Service Act (PHSA) (42 U.S.C. 296 et seq.) and for the National Institute of Nursing Research (NINR), as well as to secure authorized funding for Nurse-Managed Health Clinics (NMHCs) under Title III of the PHSA. Specifically, we urge you to provide \$313.075 million for the Nursing Workforce Development programs, \$163 million for NINR, and \$20 million for the Title III NMHC grants as each of these programs are a national priority for ensuring both the delivery and improvement of high quality health care.

As you know, ensuring all Americans receive care and that our nation has the health professionals necessary to meet the current acute and primary care demands will require a robust workforce of Registered Nurses (RNs) and Advanced Practice Registered Nurses (APRNs). Investment in the Nursing Workforce Development programs, administered by the Health Resources and Services Administration (HRSA), supported the recruitment, education, and retention of more than 347,000 nurses and nursing students as well as numerous academic nursing institutions and healthcare facilities between FY 2006 and FY 2009. However, the U.S. Bureau of Labor Statistics projects a demand on our delivery system that will necessitate the creation of 581,000 new positions by 2018, a 22% increase in the nursing workforce. APRNs and RNs rely upon support through Title VIII to complete their degrees and offset their considerable educational expenses. The Nursing Workforce Development programs are tailored specifically to addressing workforce demands, but will require enhanced funding to adequately meet the needs of our nation.

Research-based initiatives that improve acute care outcomes and promote preventative health awareness hold the key to reducing healthcare spending and promoting sustainable practices, which are at the heart of nursing science. NINR's research goals of promoting health, preventing disease, eliminating health disparities, and improving quality of life over the last 25 years has made a lasting impact on the lives of millions of Americans. Often working collaboratively with physicians and other researchers, nurse scientists are vital in setting the national research agenda.

Improving the investment in nursing science through NINR will help promote advances in our nation's healthcare system.

Finally, the *Patient Protection and Affordable Care Act* [Public Law 111-148] amended Sec. 330 of the Public Health Service Act to provide grant eligibility to Nurse-Managed Health Clinics (NMHCs) to support operating costs. NMHCs are managed by APRNs, and provide primary care and wellness services to underserved or vulnerable populations and are associated with a school, college, university or department of nursing, federally qualified health center, or independent nonprofit health or social services agency. The care provided in these sites directly contributes to positive health outcomes and savings in the long term. In one US city alone, nurses at an NMHC see their patients almost twice as frequently as other providers, and their patients are hospitalized 30% less and use the emergency room 15% less often than those of other healthcare providers. Providing funding for these clinics is a direct investment in the specific health needs of localized communities.

Please know that the undersigned organizations understand and appreciate that Congress needs to make difficult spending decisions. However, without an adequate supply of nurses, the science to support their work, and the safety net services they provide, the nation's healthcare system is not sustainable. We urge you to make the Title VIII Nursing Workforce Development programs, NINR, and Nurse-Managed Health Clinics a priority in your FY 2012 bill. Please consider our organizations available as resources to you and your colleagues on the national nursing issues facing the nation's patients.
