We also appreciate the dedicated funding for Nurse Managed Health Clinics (NMHCs) through the Nurse Education, Practice, Quality and Retention program highlighted in report language. The Nursing Community would also like to thank you for supporting a funding level of \$145.2 million for the National Institute of Nursing Research (NINR), one of the 27 institutes and centers comprising the National Institutes of Health. Investing in nursing science is crucial to ensuring the continued excellence of nursing care and evidence-based practice.
