Dear Senators Welch, Blackburn, and King, and Congressmen Mann and Neguse:

On behalf of the 48 undersigned organizations representing the Nursing Community Coalition (NCC), we thank you for introducing the States Handling Access to Reciprocity for Employment (SHARE) Act (S.1101/H.R.2332). The NCC is a cross section of education, practice, research, and regulation within the nursing profession, representing Registered Nurses (RNs), Advanced Practice Registered Nurses (APRNs),<sup>1</sup> nurse leaders, boards of nursing, students, faculty, and researchers. Together, the NCC appreciates the introduction of this important piece of legislation. We urge its advancement through committee and, ultimately, for Congress to pass the SHARE Act this year.

This bipartisan legislation makes necessary technical corrections to current law to ensure states belonging to interstate occupational licensure compacts receive federal criminal background check information through a smooth and efficient process. Currently, state licensing agencies may encounter unpredictable and inconsistent roadblocks when they request criminal background check results from the Federal Bureau of Investigation (FBI) for the purpose of vetting prospective licensees under an interstate compact. The SHARE Act provides a much-needed technical fix to this roadblock by clarifying the FBI's ability to provide background check results to state licensing agencies when related to interstate compact licensure.

As this issue relates to nurses, nearly all states require that nurses submit to a federal criminal background check. This requirement helps ensure public protection. Unfortunately, inconsistent standards, protocols, and guidance related to the background check process have sporadically hindered

or delayed the operation of several state occupational licensure compacts, including member states implementing the Nurse Licensure Compact (NLC). This issue is not new. For over a decade, state licensing agencies and stakeholders have sought a federal solution to address the problem. This is where the SHARE Act comes in to ensure licensed professionals can have licensure mobility and patients can access safe care when and where they need it.

Nurses nationwide rely on the NLC for licensure mobility. The NLC eases a barrier to entry for RNs, APRNs who hold RN licenses, and licensed practical nurses who live in one of 43 participating states and territories.<sup>2</sup> More than 2.5 million nurses nationwide hold a multistate license under the NLC, which recently celebrated 25 years of successful operation,<sup>3</sup> making it the largest and longest-operating interstate occupational licensure compact in the country. In addition, the Centers for Medicare and Medicaid Services has encouraged states to adopt the NLC as a means of supporting rural healthcare access.<sup>4</sup> The U.S. military also supports licensure compacts as a key tool in bolstering healthcare access and employment opportunities for servicemembers and their families.<sup>5</sup>

The SHARE Act clarifies and will bring consistency to the process under which a state licensing agency receives federal background check results. Further, the bill ensures criminal history record information is maintained in the same manner as requests for all occupational licenses handled at the state level. In accordance with how compacts already operate, the bill specifies that criminal history record information cannot be shared with any entity other than a state licensing agency that requests the criminal background check, maintaining strong privacy and data-security safeguards.

As organizations greatly concerned with the nation's nursing workforce and patients' access to safe care, we urge Congress to pass the SHARE Act this Congress.
