Dear Chairman Cassidy, Ranking Member Sanders, Chairman Guthrie, and Ranking Member Pallone:

On behalf of all 65 Nursing Community Coalition (NCC) member organizations, we offer our strong, united support for the Title VIII Nursing Workforce Reauthorization Act of 2025 (S.1874/H.R.3593). This bipartisan, bicameral bill is consistent with FY 2026 funding levels and provides vital resources to our current and future nursing workforce throughout the country. We encourage the Senate Committee on Health, Education, Labor and Pensions and the House Committee on Energy and Commerce to consider and pass Title VIII reauthorization as part of any health care package this year.

Members of the NCC represent the cross section of education, practice, research, and regulation within the nursing profession and fully support this legislation's goal to reauthorize the Title VIII Nursing Workforce Development Programs. Representing a profession of more than five million licensed Registered Nurses (RNs),¹ Advanced Practice Registered Nurses (APRNs),² nurse leaders, boards of nursing, students, faculty, and researchers, the NCC embodies the drive and passion to continually improve care for patients, families, and communities.

We recognize that supporting health care in all communities, including in our rural and underserved areas, requires continued investment in nursing. The Title VIII Nursing Workforce Reauthorization Act of 2025 does just that by ensuring these programs continue bolstering nursing education at all levels, supporting institutions that educate future nurses, helping recruit

and retain the nursing workforce, and ensuring the demand for nursing care is met throughout the nation. As the Committees are acutely aware, the need for nurses continues to grow. In fact, projections show that the demand for RNs will increase 5% by 2034,³ and for most APRNs by 35%.⁴ These needs are compounded by continued nurse staffing shortages and high workloads that strain the profession.

As the largest dedicated federal funding source for nurses, Title VIII programs offer a strategic and cost-effective approach to supporting the nursing workforce and patients across the country. For instance, in Academic Year (AY) 2022-2023:

- Advanced Nursing Education (ANE) programs supported more than 8,000 students and provided for “over 2 million hours of patient care and nearly 900,000 patient encounters [that] occurred in medically underserved communities.”⁵
- Graduates of Title VIII programs not only advance their education but also work in medically underserved areas. In fact, more than three-quarters of Nurse Corps providers were employed in community-based settings and 20% were in rural communities.⁶
- 74% of Nurse Faculty Loan Program (NFLP) graduates from AY 2021-2022 were in faculty positions one year later, with the majority teaching at the bachelor’s level or higher.⁷
- Programs like Nurse Education, Practice, Quality and Retention (NEPQR), supported over 10,300 nurses and nursing students, help with the development, distribution, and retention of a nursing workforce that can adapt to the population’s changing health care needs and provide the highest quality of care for all.⁸

These examples illustrate the advantage these crucial programs have in recruiting and retaining nurses in the communities they serve. This straight reauthorization will continue the important legacy that Title VIII programs have in directly connecting patients with high-quality nursing care in community health centers, hospitals, long-term care facilities, local and state health departments, schools, workplaces, and patients’ homes.

As you work to support our nation’s health, the NCC strongly encourages the Committees to swiftly consider and advance the Title VIII Nursing Workforce Reauthorization Act of 2025 (S.1874/H.R.3593).
